9. The evaluated substantially responsive Bid:

Lithon Project Consultants is the most responsive bidder.

The bids were evaluated using a two-envelope system, whereby the Technical and Financial scores of each proposal were combined to achieve a final score (Proposal Result).

In the technical evaluation, Lithon Project Consultants achieved the highest score of 91.71%.

For the financial examination, Burmeister and Partners offered the lowest bid amount of N\$ 921,274.12 making them highest scorer in terms of price.

The combined technical and financial scores resulted in Lithon Project Consultants emerging as the most responsive bidder.

Therefore, Lithon Project Consultants have obtained the highest ranked final score.
