EXECUTIVE SUMMARY OF THE BID FOR THE PROVISION OF CONSULTANCY SERVICES FOR THE PROFESSION OF PROJECT MANAGEMENT SERVICES FOR THE AUTOMATION OF THE MASS DISTANCE CHARGES: Procurement Reference no: SC/RP/RFA – 14/2021.

1. SCOPE OF SERVICES

The scope of work is to Project Manage the design, supply, installation, testing, commissioning, maintenance, and operational support of a Mass Distance Charging Automation (MDC) system and Cross Border Charging (CBC) system, which entails:

- a. MDC/CBC back-office systems including computer hardware, operating systems, and applications software
- b. MDC/CBC front-office systems including computer hardware, operating systems, and applications software
- c. MDC/CBC accounting and financial system
- d. Network switches and Uninterruptible Power Supplies
- e. GNSS on-board units (OBU's) including mounting kits, subject to the outcome of testing, legislation updates and industry engagement processes
- f. Interfaces to third party fleet management systems. These entities are to be certified as Distance Declaration Operators (DDO's). This will be subject to the outcome of testing, legislation updates and industry engagement processes
- g. RFID tags, writer/readers, and readers
- h. ANPR and overview CCTV cameras with video analytics
- i. Operational support to review and clean-up MDC and eNatis databases
- j. Operational support with checking of odometer readings
- k. Liaison and co-ordination with GSM/GPRS/3G APN service provider (separate tender)
- l. Interface to RFA ERP system
- m. Interface to eNaTIS vehicle registration system (RTMC)

- n. Establishment of Customer Service and Installation Centers (CSC) and provision of mobile installation/ compliance management facilities
- o. Implementation of new regulations by Adv Hennie Venter
- p. Civil works at border posts and police roadblocks
- q. Data communications upgrades
- r. Certification of OBUs
- s. SIM card contracts
- t. Server room construction at border posts
- u. RFID tag reader pole design and construction

2. Deliverables
