# SECTION I: INSTRUCTIONS TO BIDDERS

## 1. Rights of Public Entity

The RFA reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

## 2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (a) the Quotation Letter in Section II with its annex for Bid Securing Declaration
- (b) the List of Goods and Price Schedule Section III;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachment deemed appropriate.

You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

## 3. Validity of Quotations

The Quotation validity period shall be **90 days** from the date of submission deadline.

## 4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- (a) An original (or certified copy) of a Valid Good Standing Certificate: Social Security Commission (SSC certificates are valid only for 1-month from date of issue unless stated otherwise),
- (b) An original (or certified copy) of a Valid Certificate of Good Standing for Value Added Tax (VAT), if bidder is not registered for VAT then no VAT will be applicable in the procurement from the Ministry of Finance: Inland Revenue (the validity period of the MOF certificates is stated on the document),
- (c) An original (or certified copy) of a Valid Affirmative Action Compliance Certificate, or exemption in terms of Section 42 of the Affirmative Action Act, 1998 (these certificates are valid for 12-months from date of issue unless stated otherwise),
- (d) A certified copy of proof of business (form/type) registration (depending on the type of business entity, this can be either BIPA documents or partnership agreement).

## 5. Bid Securing Declaration

## 6. Delivery

Delivery shall be **three months** after acceptance/issue of Purchase Order. Deviation in delivery period shall not be accepted.

## 7. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Public Entity with the Bidder's name and contact information at the back of the envelope.

## 8. Submission of Quotations

Quotations should be deposited in the **Bid Box** located at **Road Fund Administration (RFA), 21 Feld Street, Windhoek, Namibia** not later than **Monday, 27<sup>th</sup> February 2023, 11h00**. Quotations by post or hand delivered should reach **Road Fund Administration (RFA), 21 Feld Street, Windhoek, Namibia** by the same date and time at latest. **Late quotations will be rejected.**

## 9. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Securing Declaration, will be posted on the website of the Public Entity and available to any bidder on request within three working days of the Opening.

## 10. Evaluation of Quotations

The Road Fund Administration shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of evaluated cost determine the lowest evaluated quotation.

## 11. Technical Compliance

Bidders shall submit along with their quotations documents, catalogues and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Public Entity's requirements.

The Specifications, Performance Requirements and Compliance Sheet details the minimum specifications of the goods/items to be supplied. The specifications have to be met but no credit will be given for exceeding the specifications.

## **12. Prices and Currency of Payment**

Quotations shall be ***fixed in Namibian Dollars*** and all payments will be made in this currency.

## **13. Award of Contract**

The Bidder having submitted the lowest evaluated responsive quotation and qualified to supply the goods shall be selected for award of contract.
