EXECUTIVE SUMMARY FOR THE BID FOR THE PROVISION OF CONSULTANCY SERVICES TO ANALYSE AND CONDUCT DATA CLEAN-UP OF THE RFA MDC LOCAL DATABASE

Procurement Reference no: SC/RP/RFA – 11/2020

1. SCOPE OF CONTRACT

The objective is to compare and do a data clean-up of the MDC Local database and ensure that all MDC Local liable vehicles are validated and reconciled with the eNaTIS database of registered vehicles and charged the correct Mass Distance Charge according to the RFA classification category.

1.1. Deliverables

The following deliverables will be required from this procurement:

- i. Analyse and compare the MDC database against the eNaTIS database,
- ii. Validate corresponding data entries,
- iii. Identify variances from the eNaTIS database, duplications and / or missing data,
- iv. Ensure alignment of data on the RFA ERP system,
- v. Ensure alignment of data on the eNaTIS database,
- vi. Identify and report to RFA on all clients whose vehicles exist on the eNaTIS system, but are not captured on the RFA MDC database and ensure that the missing data is captured,
- vii. Provide a detailed report outlining the filtering methods used and logic applied to derive the desired outcome through,
  - a) confirmation of data entries identified as accurate,
  - b) confirmation of data entries that have been amended, and
  - c) validation of the total number of vehicles liable for MDC Local in Namibia,

viii. Recommendation for system enhancements that will prevent future duplication of data and the inaccurate capturing of data through unique identifiers.

## 2. PROCUREMENT METHOD

The Request for Proposals method as provided for in terms of the Public Procurement Act (Act 15 of 2015), section 35 and through open advertised bidding as provided for by section 28.

#### 3. DATE OF INVITATION OF BIDS

The TOR document was circulated as an invitation to bidders on the 29 October 2020.

#### 4. CLOSING DATE FOR SUBMISSION OF BIDS

The closing date for all submissions was on the 30 November 2020 at 11:00 Hours.

#### 5. DATE AND PLACE OF OPENING OF BIDS

The bid opening took place on the 30 November 2020 at 11:10 at the RFA head office.

#### 6. NUMBER OF BIDS RECEIVED BY CLOSING DATE

A total of 12 bids was submitted by the closing date and time.

7.1 Deloitte & Touche failed to submit proof of a business registration document, instead they have attached a letter from the Public Accountants and Auditors Board (PAAB) confirming that Deloitte & Touche is a registered member with PAAB, which does not qualify as sufficient proof of registration of a business entity (but rather is proof membership to industry association).

- 7.2 Simasix Accounting and Consulting failed to submit proof a valid Affirmative Action Certificate, the proof submitted was that of an expired document.
- 7.3 Both Deloitte & Touche as well as Simasix Accounting and Consulting were therefore not eligible and were disqualified from technical evaluation.
- 7.4 No financial proposals were opened at this stage of the evaluation.
